Incombustible. In the event of fire, toxic fumes may form: Upon contact with metals, hydrogen gas may form (there is a risk of explosion). Do not allow extinguishing water into surface or underground water courses. Precipitate fumes formed with water.

Suitable clothing and footwear. Self-contained breathing equipment.

Clean any remains with plenty of water. Neutralize with solution of sodium carbonate.
