4. First aid measures

4.1 General indications:

4.2 Inhaling:

Take the person out into the fresh air. In the event of suffocation, proceed to provide artificial respiration. In the event sickness persists, seek medical assistance.

Wash with plenty of soap and water. Remove contaminated clothing. In the event of irritation, seek medical assistance.

Wash with plenty of water (for at least 15 minutes), keeping eyelids open. Seek medical assistance.

Incombustible. In the event of fire, toxic fumes may form: Upon contact with metals, hydrogen gas may form (there is a risk of explosion). Do not allow extinguishing water into surface or underground water courses. Precipitate fumes formed with water.

Suitable clothing and footwear. Self-contained breathing equipment.

6. Accidental release measures

6.1 Personal precautions, protective equipment and emergency procedures:

Avoid contact with the skin, eyes or clothing. Ensure adequate ventilation. Do not inhale the fumes.

Do not allow it to enter the drainage system. Avoid pollution of the soil, water supplies and drains.

Collect up with absorbent materials (Panreac General Absorbent, Kieselguhr, etc.) or, if none available, dry sand or earth, and deposit in waste containers for subsequent elimination in accordance with current legislation. Clean any remains with plenty of water. Neutralize with solution of sodium carbonate.
